## PRIVACY CONSENT FORM

### Declaration to be delivered by the athlete

In application of the rule n.13 of the Privacy regulations and in application of the European Regulations 679/16 or GDPR we inform you as follows:

1. The collected data are used only to complete the services required by the participants in order to attend the event **ADAMELLO ULTRA-TRAIL** for example: to settle the starting list, the ranking and the historical archive and to grant the services declared in the rules, as well as to send promotional and advertising material.
2. By the enrolment the athlete authorizes the Organization and the media partners, to use his/her steady and moving pictures taken during the races **ADAMELLO ULTRA-TRAIL** and other linked side events, for any advertising actions, all over the world, for the all time stated by the law and rules in effect, including also any extension of the validity time.
3. The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. The data can also be modified or cancelled by the owner.
4. The Data will not be forwarded to anyone. The technical staff of the **ADAMELLO ULTRA-TRAIL** is allowed to have access to the Data in order to guarantee the correct maintenance and eventually make the specific actions required by the legitimate owners of the registered data.
5. The Data owner has the right to get the confirmation of the existence of his/her personal data, even though the data haven't been registered yet and to get the confirmation of the data intelligible communication. In particular the owner has the right to get the following information: personal data source, treatment use and purpose, applied logics in the use of the data through electronic instruments. In addition the owner has the right to get the following services: the update, change, cancellation, transformation into anonymous form or interdiction of his/her data, in case of rule violation or inappropriate use. The owner has also the right to get a declaration that the Data change or cancellation have been transmitted to other involved subjects, except for the situations in which it is impossible such communication. In addition the owner has the right to oppose against the treatment of his/her data in case of legitimate reasons. Anyway the Data will not be used to send advertising material, to plan direct sales or to attend marketing research or sales communication.
